

Environmental Policy

Dayworth Packaging LTD converts corrugated cardboard containing at least 70% recycled material into cases and assembles Forestry Stewardship Council stamped wooden pallets. We also use and supply retail packaging products and components including string, Polyethylene and shrink wrap, postal paper bags lined with bubble wrap, wood, tar infused paper, silica gel and plastic banding.

Our packaging is essential to ensuring customer' products during transport are kept fully protected by lightweight, strong and secure covering. This results in reduced amounts of waste product and ensures continued business efficiency. Limiting the overall weight of goods transported combined with effective route planning reduces petrol consumption and associated vehicle emissions.

Dayworth packaging LTD is committed to a high level of environmental responsibility in our work, culture, service and client solutions.

Breaches of our environmental policy will be regarded as an instance of misconduct and could, as a result, lead to disciplinary proceedings.

This policy will be reviewed annually and monitored on an ongoing basis, if legislation or best practice guidance changes before an annual review is due, amendments will be made and communicated as necessary.

Identified Impacts

Dayworth Packaging LTD seeks to ensure that all identified environmental impacts are known and understood by all members of our team and that our people are aware of their effect upon the environment. Whilst delivering services to clients, we aim to offer options that impact the environment less significantly than those they may be aware of. We also seek to act as a catalyst, where appropriate, to driving a low carbon economy. Our most significant environmental impacts are:

- The running of electric machinery to convert cardboard raw material into boxes
- The running of air compressor to supply compressed air to box makers and staple guns
- The use of glue guns to glue cardboard cases and fittings
- Production of waste in the office, and use of electricity to power computers and printers
- Carbon dioxide emissions to the atmosphere from the use of fossil fuel-based energy to run our office/warehouse
- Greenhouse gas emissions to the atmosphere from the use of fossil fuels for our transportation of customer deliveries and customer visits by management
- Indirectly, the environmental impact of our contractors, suppliers and consultants delivering services for us, on our behalf, or manufacturing products.

Our Commitment

We are committed to continuously review and improve our environmental performance and limit our adverse impacts by:

- Complying with relevant legislation, regulations and any other requirements.
- Setting viable objectives and targets for each of our environmental impacts.
- Minimising our energy consumption and encouraging the use of less polluting forms of transport whenever possible e.g. car sharing, public transport;
